SOFTWARE LICENSE AGREEMENT
SECURA™ CREDENTIAL LIFECYCLE MANAGEMENT SOFTWARE

This Software License Agreement (the "License") is a binding agreement between Entrust Corporation ("Entrust") as licensor and the person or entity identified in the applicable Order Form as licensee ("Customer") for the Secura™ Credential Lifecycle Management Software (the "Software"). BY DOWNLOADING THE SOFTWARE, USING THE EQUIPMENT THAT CONTAINS THE SOFTWARE, CLICKING ON THE "ACCEPT" BUTTON OR OPENING THE SOFTWARE PACKAGE YOU ARE CONSENTING TO BE BOUND BY THIS LICENSE AND REPRESENT AND WARRANT THAT YOU HAVE THE RIGHT, POWER AND AUTHORITY TO ENTER INTO THIS LICENSE ON BEHALF OF CUSTOMER AND TO BIND CUSTOMER TO ITS TERMS. IF YOU DO NOT AGREE TO ALL OF THE TERMS OF THIS LICENSE, IMMEDIATELY DISCONTINUE USE OF THE SOFTWARE AND RETURN IT AND ALL COPIES TO ENTRUST OR THE PARTY FROM WHOM IT HAS BEEN LICENSED.

1. Definitions. As used in this License:

1.1 "Credentials" means the IDs, passports, driver's licenses or other documents or certificates used to validate identity, qualifications or other characteristics as part of a specific Credential Program which is managed by the Software. In the event multiple credentials are issued under a single Credential Program (e.g., combined national ID and passport) each type of credential shall be deemed to be a separate Credential and may require additional licenses and the payment of additional fees.

1.2 "Credential Program" means the specific program for which a particular type of Credential is managed (e.g., a passport project or national ID program).

1.3 "Documentation" means the electronic or printed material describing the functions, features or specifications of the Software and made available by Entrust. Documentation excludes all marketing materials, proposals, demonstrations and content made available for instructional, sales or informational purposes only.

1.4 "Licensed Number of Credentials" means the maximum number of Credentials which may be managed by the Software as set forth in the applicable Order.

1.5 "Licensed Number of Devices" means the maximum number of Printers, Servers and Workstations which may be utilized by the Software as set forth in the applicable Order.

1.6 "Order Form" means the Entrust sales order form or form provided by a Entrust authorized entity that identifies the Licensed Number of Devices, the Licensed Number of Credentials, other licensing metrics for the Software and other terms applicable to the transaction.

1.7 "Party" means Entrust or Customer, and **"Parties"** means Entrust and Customer.

1.8 "Printers" means the printers and/or other issuance devices identified in an applicable Order Form which may be utilized by the Software.

1.9 "Server" means the physical hardware server(s) (e.g., production, test, backup) upon which the Software may be installed.

1.10 "Software" means the Entrust Secura software and media described in an Order Form, any upgrades, updates, and enhancements provided by Entrust to Customer under a separate maintenance or support agreement between the Parties for that same Software or provided by a third party to Customer, and any permitted copies of that Software and applicable Documentation.

1.11 "Workstations" means the enrollment or issuance workstations and/or enrollment devices identified in an applicable Order Form which may be utilized by the Software.

2. License Grant. Subject to Customer's compliance with the terms of this License and payment of applicable fees, Entrust hereby grants Customer a perpetual, non-exclusive, revocable, non-transferrable, non-sublicensable license to use and allow its employees and authorized contractors to use the Software on up to the Licensed Number of Devices to produce and/or manage the Licensed Number of Credentials only for the specific Credential Program for which the Software is licensed, and only for Customer's internal business purposes.

3. Archival Copy. Customer may make one (1) archival copy of the Software at no additional charge provided Customer affixes to such copy all copyright, confidentiality, and other proprietary notices that appear on the original.

4. Disaster Recovery Copies. Customer may make additional copies of the Software for the charges set forth in

the accompanying Order Form for disaster recovery purposes only. In such event, the Server on which the Software is installed must be turned off at all times, except for (i) database synchronization between primary and disaster recovery databases or (ii) disaster recovery. Except in the event of a disaster, the disaster recover Server must be configured in such a way that it cannot be used in a production environment.

5. Non-Production Software. Any Software identified in an Order Form for testing or demonstration purposes, beta software, any temporary software modules or any Software for which Entrust does not receive a license fee ("Non-Production Software") may only be used by Customer for its internal development and testing or other such designated uses, but not for production.

6. Installation and Support. Except as otherwise agreed in an Order Form, Customer is responsible at its expense for installation of the Software. Unless otherwise authorized by Entrust in writing, only Customer, Entrust or an authorized Entrust service provider, may install, maintain, host or perform testing or audits on the Software. Software support and maintenance are not included under this License and require the signing of Entrust's separate software maintenance agreement and payment of applicable fees.

7. Restrictions. Except to the extent expressly authorized in this License or otherwise by Entrust in writing, Customer shall not and shall not allow any third party to: (i) decompile, disassemble, or reverse engineer the Software (except to the extent permitted under applicable law); (ii) modify or create any derivative works (including, without limitation, translations, transformations, adaptations or other recast or altered versions) based on the Software, or alter the Software in any way; (iii) merge the Software with any other software or product not supplied by Entrust; (iv) use, copy, sell, sublicense, lease, rent, loan, assign, convey or otherwise transfer the Software; (v) distribute, disclose or allow use of the Software, in any format, through any timesharing service, service bureau, network or by any other means, to or by any third parties; (vi) remove or modify any copyright, confidential and/or proprietary markings, legends or restriction which are in the Software originally supplied to Customer; or (vii) violate any obligations with regard to Entrust's confidential information.

8. Ownership. Customer acknowledges and agrees that the Software and all rights, title and interests therein constitute intellectual property of Entrust and are the sole property of Entrust or its licensors. Customer receives no rights, title or interests in the Software except as expressly set forth in this License. All rights not expressly granted to Customer in this License are expressly reserved by Entrust. Customer agrees that it will make the Software available only to employees and authorized agents with a need to know, who are obligated to comply with all restrictions contained in this License, and to maintain the secrecy of the Software and all other confidential information related thereto including, but not limited to, source code, object code, benchmark tests and audit results. Customer agrees not to disclose, provide, or otherwise make available Entrust's confidential information in any form to any third party without the prior written consent of Entrust. Customer agrees further to implement reasonable security measures to protect such confidential information. Customer is responsible for the compliance of all users with these obligations.

9. Limited Warranty. Entrust warrants that the Software will perform materially and substantially in compliance with Entrust's applicable Documentation in effect at the time of license for a period of ninety (90) days from delivery ("Warranty Period"). Except for the foregoing, the Software is provided AS IS. Entrust does not warrant that use of the Software will be uninterrupted or error free or that the Software will meet Customer's requirements, whether or not known to Entrust. If Customer notifies Entrust of a breach of this warranty in writing during the Warranty Period, Entrust will use commercially reasonable efforts to provide Customer with an error correction or work-around which corrects the defect. Any such error correction or work-around provided by Entrust will not extend the original Warranty Period. The foregoing remedy is Entrust's sole liability and Customer's exclusive remedy for any breach of the Software warranty. No dealer, distributor, reseller or agent of Entrust is authorized to make any modification or addition to the warranty and remedies stated above.

The above warranty will not apply (i) if the Software is used with any hardware or software not specified in the Documentation; (ii) if any modifications are made to the Software by Customer or any third party; (iii) to defects in the Software due to accident, abuse, neglect or improper installation, maintenance or use by Customer; or (iv) if reported defects cannot be reproduced by Entrust.

The above limited warranty and the intellectual property indemnity below DO NOT apply to any Non-Production Software. All Non-Production Software is provided AS IS without any warranty whatsoever.

10. DISCLAIMER OF WARRANTIES/LIMITATION OF LIABILITY. EXCEPT AS SPECIFICALLY STATED HEREIN, ENTRUST HEREBY DISCLAIMS ANY AND ALL WARRANTIES, EXPRESS OR IMPLIED, WITH REGARD TO THE SOFTWARE, INCLUDING, BUT NOT LIMITED TO, ANY IMPLIED WARRANTY OF MERCHANTABILITY, FITNESS FOR A PARTICULAR PURPOSE OR NONINFRINGEMENT OF THIRD PARTY INTELLECTUAL

PROPERTY RIGHTS. TO THE FULL EXTENT PERMITTED BY LAW, THE DURATION OF ANY APPLICABLE STATUTORILY REQUIRED WARRANTIES SHALL BE LIMITED TO THE WARRANTY PERIOD. IN NO EVENT SHALL ENTRUST BE LIABLE TO CUSTOMER FOR INDIRECT, INCIDENTAL, SPECIAL, CONSEQUENTIAL OR PUNITIVE DAMAGES, LOSS OR DAMAGE TO DATA OR LOSS OF ANY FUTURE REVENUE, INCOME OR PROFITS ARISING OUT OF OR IN CONNECTION WITH THIS LICENSE OR THE USE OF THE SOFTWARE, UNDER ANY THEORY OF LAW, EVEN IF ENTRUST HAS BEEN ADVISED OF THE POSSIBILITY OF SUCH DAMAGES. IN NO EVENT SHALL ENTRUST'S AGGREGATE LIABILITY TO CUSTOMER FOR DAMAGES ARISING OUT OF OR IN CONNECTION WITH THIS LICENSE OR THE USE OF THE SOFTWARE, UNDER ANY THEORY OF LAW, EXCEED THE SUM OF ALL LICENSE FEES ACTUALLY PAID TO ENTRUST BY CUSTOMER FOR THE SOFTWARE.

11. Intellectual Property Indemnity. Entrust shall defend, at its expense, Customer from any action brought against Customer to the extent that it is based upon a claim that the Software, or any part thereof, directly infringes a United States patent, copyright, trade secret or other proprietary right of any third party ("Claim"). Entrust will indemnify Customer for the damages finally awarded against Customer or settled by agreement which are attributable to such Claim. Entrust's defense and indemnification obligations are subject to and limited by the following: (a) that Customer promptly notifies Entrust in writing of any knowledge or notice Customer has concerning the Claim, or the possibility thereof; (b) that Customer allows Entrust to assume immediately and undertake the sole control of the defense of any such action and all negotiations for its settlement (provided that no settlement that imposes any liability or obligation on Customer will be made without Customer's prior written consent, which will not be unreasonably withheld); (c) that Customer cooperates with Entrust's reasonable requests for assistance in conducting such defense; and (d) that Entrust has no obligation to reimburse Customer for any such expenses incurred by Customer following Entrust's receipt of notification and its assumption of such defense. Should the Software, or any part thereof, become or in Entrust's opinion be likely to become the subject of a Claim, Customer shall permit Entrust at Entrust's sole option and expense: (i) to procure for Customer the right to continue using the Software; (ii) to make available a modified or replacement product so that Customer's Software becomes non-infringing; or (iii) if Entrust determines that it is unable to perform either of alternatives (i) or (ii), then at Entrust's sole option to take possession of the allegedly infringing Software after giving Customer thirty (30) days prior written notice and to reimburse Customer for the purchase price of the Software depreciated over a 3-year period from the date of purchase on a straight line basis less any unpaid amount of such price. All costs of such repossession shall be at Entrust's sole expense.

Entrust shall have no obligations or liability to Customer under any provisions of this Section with respect to any claim, judgment, or finding of patent, copyright, trade secret or other proprietary right infringement which is based upon: (v) the combination or utilization of the Software with equipment, software, supplies or devices not furnished or approved by Entrust; (w) use of the Software in any manner that is inconsistent with the purpose for which it was designed or contrary to the explicit provisions in Entrust's Documentation or specifications therefor; (x) modification of the Software without Entrust's explicit prior written approval or in any manner in accordance with designs, specifications or instructions provided by Customer; (y) claims that result from the negligent or willful misconduct of Customer; or (z) Customer's use of a superseded or replaced version of the Software, to the extent that the obligation or liability would have been avoided by the use of a then current version which Entrust makes available to Customer.

THE FOREGOING STATES THE ENTIRE LIABILITY OF ENTRUST AND SOLE REMEDY OF CUSTOMER WITH RESPECT TO INFRINGEMENT OF PATENTS, COPYRIGHTS, TRADE SECRETS OR OTHER PROPRIETARY RIGHTS ARISING OUT OF OR BASED UPON THE LICENSE OR USE OF THE SOFTWARE AND ENTRUST SHALL HAVE NO OTHER LIABILITY OR OBLIGATION TO CUSTOMER OF ANY KIND, INCLUDING, BUT NOT LIMITED TO, LOST BUSINESS OPPORTUNITY, LOST REVENUE, LOST PROFIT, LOST EFFICIENCY, REPLACEMENT COSTS OR OTHER CONSEQUENTIAL OR INDIRECT LOSSES OR DAMAGES, ARISING OUT OF OR RELATED THERETO.

12. Audit. Customer grants to Entrust the right to examine its books, records and accounts during Customer's normal business hours to verify compliance with the terms of this License. In the event such audit discloses that any of the Licensed Number of Devices or Licensed Number of Credentials has been exceeded, Customer shall promptly pay to Entrust the appropriate license fee applicable to the excess amount(s) at Entrust's then current list prices. Customer is responsible for the costs of the audit in the event the audit reveals underpayment of five percent (5%) or more in Software license fees. In the event the audit discloses any other non-compliance with this License, Customer agrees to remedy such non-compliance immediately. In either event Entrust reserves the right to terminate this License.

13. Export. Software, including technical data, is subject to U.S. export control laws, including the U.S. Export Administration Act and its associated regulations, and may be subject to export or import regulations in other

countries. Customer agrees to comply strictly with all such regulations and acknowledges that it has the responsibility to obtain licenses to export, re-export, or import the Software.

14. Termination. Customer may terminate this License at any time by providing Entrust with thirty days prior written notice. Entrust may terminate this License and/or any Order Form if any invoices which are not disputed in good faith are not paid by Customer within 15 days after notice of late payment or if Customer does not cure any other material breach of the Agreement within 30 days after written notice of breach. In the event of termination of this License for any reason, Customer agrees either to (a) destroy all copies of the Software, including any Documentation, and certify such destruction to Entrust in writing; or to (b) return the Software and Documentation to Entrust. Entrust shall not be required to refund any part of fees paid hereunder in the event Customer terminates this License.

15. General. Customer may not assign this License, in whole or in part, whether by sale, merger, operation of law, change of control or otherwise, without the prior written consent of Entrust. If any provision of this License is held to be invalid by a court of competent jurisdiction, the remaining provisions will nevertheless remain in full force and effect. The Parties agree to re-negotiate in good faith any term held invalid and to be bound by the mutually agreed substitute provision. The failure of either Party to enforce any term or condition of this License shall not constitute a waiver of that Party's rights to enforce subsequent breaches of any term or condition under this License. This License shall be governed by and construed in accordance with the laws of the State of Minnesota, USA, without reference to its conflict of laws principles. The Parties expressly agree that any legal proceeding arising out of this License shall be brought in the Federal or State courts located in Hennepin County, Minnesota, and irrevocably submit to the exclusive jurisdiction of such courts. Any notices required to be given under this License shall be in writing and addressed as set forth in this License or to such different address as a Party may designate by notice. Notices shall be effective when delivered personally or by recognized overnight courier service, signature required. This License and the applicable Order Form(s) represents the only agreement between the Parties concerning the subject matter hereof and supersedes all prior representations, understandings and agreements whether written or oral. Conflicting or additional terms contained in a purchase order or similar document issued by Customer shall not amend the terms of this License and shall be of no force or effect notwithstanding any statements to the contrary made in such document. This License may not be altered, amended or modified except by formal agreement in writing by the Parties.
