CD820 Instant Issuance System

INSPECTION OF PRODUCT UPON RECEIPT

The following warranty applies to your Entrust™ CD820 Instant Issuance System (“System”).

You must examine all components of your System immediately upon receipt. If any component is missing, damaged or visibly defective, you must notify Entrust or the Entrust authorized service provider who sold you the product, within 30 days from the date of delivery of the product. If you fail to give notice as required, you will be deemed to have accepted the product and waived any claim you may have against Entrust and/or the Entrust authorized service provider for damage or defects discoverable at delivery.

PRODUCT WARRANTY

Entrust warrants that a new System will be free from defects in materials or workmanship for a period of 36 months from the date of shipment from Entrust, or, with proof of purchase, from the date of purchase by End-User Customer, whichever is later. The warranty for a factory-refurbished System is 90 days.

If the System proves to be defective in materials or workmanship during the warranty period, Entrust will at its option either repair or replace the System or refund the purchase price. Any new System that is repaired or replaced under the warranty will be warranted for the longer of the remainder of the original warranty period or 90 days. A factory-refurbished System that is repaired or replaced under the warranty will be warranted for the remainder of the original warranty period.

PRINthead WARRANTY

Entrust warrants that the thermal printhead delivered with your System (“Printhead”) will be free from defects in materials or workmanship for a period of 36 months from the later of the date of shipment from Entrust, or, with proof of purchase, from the date of purchase of the System by End-User Customer

If the Printhead proves to be defective in materials or workmanship during the warranty period, Entrust will at its option either repair or replace the Printhead or refund its purchase price, pro-rated to reflect the period of its effective use. A Printhead that is repaired or replaced under the warranty will be warranted for the longer of the remainder of the original warranty period or 90 days.

All Printheads replaced under warranty will become the property of Entrust.

EXCEPTIONS

System or Printhead replacements, repairs, adjustments or parts replacements that are the result of accident, force majeure, abuse, misuse, use in an unsuitable operating environment, unauthorized modification or maintenance, or the use of peripherals, supplies or software that are not supplied by Entrust are not covered by the warranty and will be charged using Entrust's then-current rates. All parts replaced under warranty will become the property of Entrust.

WARRANTY RETURN PROCEDURE

In order to make a warranty claim, you must first contact either Entrust (see below) or the Entrust authorized service provider noted on the packing slip. You will be responsible for packaging the warranted item and for the cost of freight and insurance to ship it to the designated Entrust or authorized service provider location. Entrust or the authorized service provider will bear the cost of freight and insurance to return the item to you.
