The nShield TSOP provides secure and auditable time signing for electronic business transactions and document to provide authoritative proof of when an event occurred while ensuring the time stamps are secure, authentic, and auditable.

nShield TSOP operates within the certified boundary of the nShield Solo hardware security module (HSM), issuing time stamps that enforce the validity and legal weight of digital signatures and dates on digital documents. Unlike software-based systems in which administrators can easily manipulate time, the nShield TSOP protects time-stamping keys using nShield Solo tamper-resistant HSMs.
